

## **Definitions**

**BCLC** means British Columbia Lottery Corporation.

**MBLL** means Manitoba Liquor and Lotteries Corporation.

**SaskGaming** means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

### Eligible Participant(s) means:

- a) <u>a British Columbia resident, nineteen (19) years of age or older with an open</u> PlayNow.com account, who is not a
  - BCLC employee; or
  - Family or household member of a BCLC employee, or
- b) <u>a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com</u> account, who is not an:
