

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

CTW(s) means chance(s) to win a Prize.

Drawn Entrant means an individual whose name is drawn to win a Prize as a result of the Prize Draw.

Prize(s) means:

- In British Columbia, one (1) cash prize of \$1,000 CDN, to be deposited to the winner's PlayNow Account.
- In Manitoba, one (1) cash prize of \$1,000 CDN, to be deposited to the winner's PlayNow Account.
- In Saskatchewan, one (1) cash prize of \$1,000 CDN, to be deposited to the winner's PlayNow Account.

Prize Draw means the random draws conducted by BCLC or its agent for the Prizes on August 10, 2023 or as soon as practical thereafter.

Prize Winner(s) means the Drawn Entrant or Reserve Drawn Entrant who fulfills all of these Promotion conditions.

Eligible Participant(s) means:

- In British Columbia, a British Columbia resident, nineteen (19) years of age or older
- In Manitoba, a Manitoba resident, eighteen (18) years of age or older
- In Saskatchewan, a Saskatchewan resident, nineteen (19) years of age or older

Qualified Entrant(s) means:

- A British Columbia resident, with an active PlayNow.com account, who is not a:
 - BCLC employee; or
 - Family or household member of a BCLC employee, or
- A Manitoba resident, with an active PlayNow.com account, who is not an:
 - MBLL employee; or
 - Immediate family member of an MBLL employee, defined as father, mother, brother, sister, spouse

(including common-law), child or ward of the employee, or

- A Saskatchewan resident, with an active PlayNow.com account, who is not:
 - A SIGA or SaskGaming employee; or
 - An immediate family member of a SIGA or SaskGaming employee, defined as father, mother, brother, sister, spouse (including common-law), child or ward of the employee.

Provided that:

- Individuals who are currently self-excluded or who self-exclude at any time during the Promotion Period from PlayNow.com are not Qualified Entrants and are not eligible to win a Prize.
- Individuals that are currently barred or are barred at any time during the Promotion Period from PlayNow.com or a British Columbia, Manitoba or Saskatchewan gaming facility are not Qualified Entrants and are not eligible to win a Prize.



Reserve Drawn Entrant means an individual whose name is drawn as a backup as a result of the Prize Draw and who becomes a Qualified Entrant in the event that the original Drawn Entrant becomes disqualified.

Promotion Period means

British Columbia (BC)

• The promotion period is from 00:00:00 am PT on Tuesday, July 4, 2023 to 23:59:59 pm PT on Sunday, July 31, 2023 ("Promotion Period").

Manitoba (MB)

• The promotion period is from 2:00:00 am CDT on Tuesday, July 4, 2023 to 1:59:59 am CDT on Tuesday, August 1, 2023 ("**Promotion Period**").

Saskatchewan (SK)

• The promotion period is from 1:00:00 am CST on Tuesday, July 4, 2023 to 0:59:59 am CST on Tuesday, August 1, 2023 ("Promotion Period").

Token means a PlayNow.com Casino Freeplay token.

Wagering Requirement means the minimum dollar value on eligible games a player must spend before they are eligible to withdraw their winnings generated from Tokens.

How to Receive a Casino Welcome Offer Token

- 1. To receive a \$50 casino welcome offer Token, an Eligible Participant must complete the following steps in order during the Promotion Period.
 - a. Register a new PlayNow.com account during the Promotion Period;
 - b. Correctly submit the promo code during registration: REGISTERANDWIN;
 - c. Make a single initial deposit of at least \$25 into your PlayNow.com account after registering for PlayNow.com ("Deposit Requirement"); and
 - d. Spend a cumulative amount of at least \$25 on any PlayNow.com Casino games (excludes Live Casino) ("Spend Requirement").
- 2. Casino welcome offer Tokens are only available for Eligible Participants who do not have an existing PlayNow.com account.
- Tokens cannot be used to meet the Deposit Requirement or Spend Requirement as outlined above.
- 4. Once credited to your account, the casino welcome offer Token must be used within 14 days. Tokens will not be reissued following expiration.
- 5. Tokens awarded through this Promotion may only be used for wagering on PlayNow.com casino games (excluding live casino).

Wagering Requirement Rules

a. The Wagering Requirement for the casino welcome offer Token is 30 times the value of



redeemed Tokens. You will meet the Wagering Requirement when the total dollar value of wagers made with the Token add up to 30 times the value of the Token.

- i. For example, for a \$10 Token, the Wagering Requirement = \$10 x 30 = \$300 (\$10 Token + \$290 play through of winnings). The Wagering Requirement is met when a player wagers the \$10 Token and \$290 of winnings from that original Token on eligible games.
- b. Until the Wagering Requirement is met, any winnings generated from the Token will be deposited in your Held Funds account. You can play eligible games with Held Funds, but you cannot withdraw Held Funds from your account.
- c. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com

- An Eligible Participant may receive a maximum of one (1) casino welcome offer Token during the Promotion Period.
- 7. Registration offers are based on first deposit and are limited to one per player.

How to Win a Prize

There are 3 ways for a Qualified Entrant to earn a CTW:

- 1. A Qualified Entrant who completes the requirements outlined in these conditions under "How to Receive your Casino Welcome Offer Token" and receives a \$50 casino welcome offer Token will automatically earn one (1) CTW.
- A Qualified Entrant who registers for a PlayNow.com account during the Promotion Period and receives an alternative welcome offer Token in accordance with separate applicable conditions must go to the 'My Promotions' page of their PlayNow.com account and enter the promo code "REGISTERED". Once the promo code has been entered, a Qualified Entrant will automatically receive one (1) CTW.

- 3. No purchase necessary
 - Qualified Entrants may earn one (1) CTW by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Marketing. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: name, mailing address with postal code, phone number and email address. A maximum of one (1) No-Purchase Necessary entry may be submitted per person in this promotion. Any mailing containing more than one entry, including multiple mail-ins by the same person, will be discarded, including any otherwise valid entry. Mail-in entries must be received by the close of the Promotion Period in order to be eligible for a Prize.



Chances to Win

- A Qualified Entrant may only participate in this contest in their province of residence.
- Qualified Entrants may earn a maximum of one (1) CTW.

Odds of Winning

 The odds of being selected as a Drawn Entrant are dependent on the number of eligible CTWs for each province.

Prize Draw

- The Prize Draw for each province will be conducted from CTWs earned by Qualified Entrants during the Promotion Period.
- BCLC, or MBLL or SIGA in conjunction with BCLC, will determine if each Drawn Entrant is a Qualified Entrant.
