

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Eligible Games means the PlayNow.com casino slot games listed on www.playnow.com/jackpot-cash-drop landing page.

Eligible Participant(s) means:

For British Columbia:

• a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account,

For Manitoba:

- a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account, For Saskatchewan:
 - a Saskatchewan resident, nineteen (19) years of age or older with an active PlayNow.com account.

Promotion Period means:

For British Columbia:

• The Promotion Period starts at 12:00:00 PM PT on Friday, February 14th, 2025, and will run no later than February 28th, 2025, at 21:59:59 PM PT

For Manitoba:

 The Promotion Period starts at 2:00:00 PM PT on Friday, February 14th, 2025, and will run no later than February 28th,2025, at 2359:59 PM CST

For Saskatchewan:

The Jackpot Validity Period is 2:00:00 PM – 23:59:59 PM CT

For Saskatchewan

The Jackpot Validity Period is 2:00 PM – 23:59:59 PM CT

Jackpot Cash Drop Widget means the Prize Engine that needs to be launched to win a Promotional Jackpot. It is available to be launched each day during the Jackpot Validity Period, but will disappear prior to the end of the Jackpot Validity Period if all Promotional Jackpots have been awarded for the day.

Inactive State means the Jackpot Cash Drop Widget will display the total dollar value of the next Promotional Cash Drop, but is not awarding Promotional Jackpots.

Jackpot Cash Drop Promotion Conditions



Active State means the Jackpot Cash Drop Widget has triggered the Promotional Cash Drop, and there are ten (10) Promotional Jackpots available to be won.

Promotional Jackpot means the cash jackpot prize to be awarded in this promotion.

- Each Promotional Jackpot is one (1) prize of \$2,500
- There are a total of one hundred and forty (140) Promotional Jackpots available to be won.

Promotional Cash Drop means the daily allotment of prizes available to be distributed during a Jackpot Validity Period.

- There are fourteen (14) Promotional Cash Drops of ten (10) Promotional Jackpots.
- There will be one (1) Promotional Prize Drop every day the during the Promotion Period.

How to Participate

 - e. When a Promotional Cash Drop occurs, up to ten (10) Promotional Jackpots will be available to be randomly awarded to eligible players during the Jackpot Validity Period.
 - i. If not all ten (10) prizes are awarded prior to the end of the Jackpot Validity Period, the widget will disappear, and the Promotional Cash Drop will continue the next day to distribute the remaining prizes of that drop.
 - Once the previous day's Promotional Cash Drop is complete, the Widget will return the Inactive State until the current days Promotional Cash Drop is triggered.
 - ii. If all ten (10) Promotional Jackpots are awarded during the Jackpot Validity Period, the widget will disappear until the start of the next day's Jackpot Validity Period.
 - f. A player must be actively playing an Eligible Game to be awarded a Promotional Jackpot.
- 2. When the Jackpot Cash Drop Widget is in the Active State, it will display how many Promotional Jackpots are available to be won and count down as each Promotional Jackpot is awarded.
- 3. There are a total of one hundred and forty (140) Promotional Jackpots, each with a value of \$2,500. The total value of Promotional Jackpots available to be won is \$350,000.
