

Match Deposit Mayhem Promotion – Conditions

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Casino Match Deposit Free Play means a free play awarded with a value equal to the player's deposit that is awarded through this promotion and may be used to wager on PlayNow.com in accordance with the Wagering Requirement rules.

Eligible Games means PlayNow.com casino slot games, excluding live casino and table games, subject to availability.

Held Funds means the account where a player's winnings from a free play with a wagering requirement in progress are held.

Eligible Participant(s) means:

- a British Columbia resident, nineteen (19) years of age or older with an open PlayNow.com account, who is not a:
 - BCLC employee; or
 - Family or household member of a BCLC employee, or
- A Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account, who is not an:
 - MBLL employee; or
 - Immediate family member of an MBLL employee, defined as father, mother, brother, sister, spouse (including common-law), child or ward of the employee, or
- a Saskatchewan resident, nineteen (19) years of age or older with an open PlayNow.com account.

Promotion Period means:

For British Columbia:

• The Promotion Period is from 00:00:00 PST on Tuesday, August 6, 2024, to 23:59:59 PST on Monday, September 2, 2024.

For Manitoba:

• The Promotion Period is from 02:00:00 CDT on Tuesday, August 6, 2024, to 01:59:59 CDT on Tuesday, September 3, 2024.

For Saskatchewan:

• The Promotion Period is from 01:00:00 CST on Tuesday, August 6, 2024, to 00:59:59 CST on Tuesday, September 3, 2024.

Wagering Requirement means the minimum dollar value on Eligible Games a player must spend before they are eligible to withdraw their winnings generated from Casino Match Deposit Free Play.

How to Participate

- 1. To receive a Casino Match Deposit Free Play under this Promotion, you must complete the following steps, in the following order:
 - a. Register for an account on PlayNow.com or log into your PlayNow.com account.
 - b. Enter the "**Promotion Code**" that corresponds during the applicable "**Validity Period**", as set out in the table below, in the "My Promotions" section of PlayNow.com.
 - c. Make a single, minimum deposit into your PlayNow.com account after registering for PlayNow.com for your province of residence ("**Deposit Requirement**") as follows:

 - In British Columbia, the Spend Requirement is 100% of your deposit, up to one thousand dollars (\$1,000.00).
 - In Manitoba, the Spend Requirement is 100% of your deposit, up to one thousand dollars (\$1,000.00).
 - In Saskatchewan, the Spend Requirement 100% of your deposit, up to one thousand dollars (\$1,000.00).
 - e. Eligible Participants will then receive the following Casino Match Deposit Free Play:
 - In British Columbia, a Casino Match Deposit Token equivalent to your deposit, up to one thousand dollars (\$1000.00).
 - In Manitoba, a Casino Match Deposit Token equivalent to your deposit, up to one thousand dollars (\$1000.00).
 - In Saskatchewan, a Casino Match Deposit token equivalent to your deposit, up to one thousand dollars (\$1000.00).

There is a maximum of \$4,000 that can be awarded in free play.

- f. A Promotion Code must be entered during the corresponding Validity Period in order to be eligible for a Casino Match Deposit Free Play.

- 3. Once credited to your account, the Casino Match Deposit Free Play must be used within 7 days. Casino Match Deposit Free Play will not be reissued following expiration.
- 4. Each Casino Free Play awarded from this Promotion have a 30x Wagering Requirement applied to them.

Wagering Requirement Rules

- The Wagering Requirement for each Casino Match Deposit Free Play is thirty (30) times
 the value of redeemed Casino Match Deposit Free Play. You will meet the Wagering
 Requirement when the total dollar value of wagers made with the Casino Match Deposit
 Free Play add up to thirty (30) times the value of the Casino Free Play.
 - For example, for a \$10 Casino Match Deposit Free Play, the Wagering Requirement = \$10 x 30 = \$300 (\$10 Token + \$290 play through of winnings). The Wagering Requirement is met when a player wagers the \$10 Casino Free Play and \$290 of winnings from that original Casino Match Deposit Free Play on eligible games.
- Until the Wagering Requirement is met, any winnings generated from the Casino Match Deposit Free Play will be deposited in your Held Funds account. You can play eligible games with Held Funds, but you cannot withdraw Held Funds from your account.
- Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com
