



## SuperMarch Casino Free Play Offer (“Promotion”)

### Definitions

**BCLC** means British Columbia Lottery Corporation.

**SuperMarch Casino Free Play** means a “Free Play” with a value equal to the player’s lottery spend (up to \$1,000) that is awarded through this Promotion and may be used to wager on PlayNow.com in accordance with the Wagering Requirement rules.

**Eligible Participant(s)** means:

- a British Columbia resident who is nineteen (19) years of age or older, or a Manitoba resident who is eighteen (18) years of age or older;
- has an active PlayNow.com account;
- not a BCLC employee;
- not self-excluded from PlayNow.com at any time during the Promotion Period; and
- not prohibited from PlayNow.com or self-excluded from a gaming facility operated by MBLL or BCLC at any time during the Promotion Period.

**Promotion Period:** As per the below chart, each week is a separate Promotion Period:

**Wagering Requirement** means the minimum dollar value on eligible games a player must spend before they are eligible to withdraw their winnings generated from Tokens.

### Promotion Conditions

1. To receive a SuperMarch Casino Free Play, an Eligible Participant must complete the following steps in order during the Promotion Period:

- a. login to your PlayNow.com account;
- b. enter the Promo Code corresponding to the relevant Promotion Period (see above table) on the ‘My Promotions’ page on PlayNow.com;
- c. spend up to \$1,000 on any of the following eligible PlayNow.com Lottery games (“**Spend Requirement**”):
  - i. in BC: Lotto Max, Lotto 6/49, BC/49, Daily Grand & Extra; or
  - ii. in MB: Lotto Max, Lotto 6/49, Daily Grand, WESTERN MAX, WESTERN 649 & EXTRA
- d. Eligible Participants will then receive a SuperMarch Casino Free Play equivalent to the Eligible Participant’s total lottery spend during the Promotion Period, up to one thousand dollars (\$1,000); and
- e. SuperMarch Casino Free Plays have a 30x Wagering Requirement. See below for Wagering Requirement Rules.

### **Wagering Requirement Rules**

- i. The Wagering Requirement for the **SuperMarch Casino Free Play** is 30 times the value of the **SuperMarch Casino Free Play** received. You will meet the Wagering Requirement when the total dollar value of wagers made with the Token add up to 30 times the value of the Token.
    - Therefore, for a \$10 Free Play, the Wagering Requirement =  $\$10 \times 30 = \$300$  (\$10 Token + \$290 play through of winnings)
  - ii. The Wagering Requirement is met when a player wagers the \$10 Free Play and \$290 of winnings from that original token on eligible games.
  - iii. Until the Wagering Requirement is met, any winnings generated from the Free Play will be deposited separately in Held Funds (“**Held Funds**”). You can play eligible games with Held Funds, but you cannot withdraw Held Funds from your account.
  - iv. Once the Wagering Requirement is met, any Held Funds remaining will be transferred to your cash balance and can be withdrawn from your account or used on any game on PlayNow.com

2. SuperMarch Casino Free Play will be issued 2-5 business days following the end of the Promotion Period
  3. SuperMarch Casino Free Play awarded through this Promotion may be used for

wagering on PlayNow.com casino games, including Live Casino (excludes baccarat and roulette).

4. Free play cannot be used to meet the Spend Requirement, as outlined above.
5. Once credited to your PlayNow.com account, the SuperMarch Casino Free Play must be used within fourteen (14) days. SuperMarch Casino Free Play will not be reissued following expiration.
6. An Eligible Participant may receive a one (1) SuperMarch Casino Free Play for each Promotion Period, for a total maximum of three (3) SuperMarch Casino Free Plays.
7. The Promo Code expires at the end of each Promotion Period.
8. If validation of your PlayNow.com account is pending, the SuperMarch Casino Free Play will be deposited when the PlayNow.com account is validated providing all conditions have been met.
9. If you are having difficulty receiving the SuperMarch Casino Free Play, or any issues with wagering requirements or held Funds from this offer, you must call Customer Support with code error issues during the relevant Promotion Period. Any inquiries after the Promotion Period has lapsed will not be considered as eligible for the SuperMarch Casino Free Play.

### **General Conditions**
