

Pre-Match Football Live Free Bet Conditions

- To participate in this Pre-Match Football Live Free Bet promotion (the "Promotion") you must:
 - a. be a British Columbia or Saskatchewan resident and be 19 years of age or older, or a Manitoba resident and be 18 years of age or older, and
 - b. have an active PlayNow.com account.
- This Promotion starts on Tuesday, October 15, 2024 at 12:00:00 am PT / 1:00:00am CST / 02:00:00 am CT and ends on Monday, October 21, 2024 at 11:59:59 pm PT / Tuesday, October 15 at 12:59:59 am CST / 1:59:59 am CT (the "Promotional Period").
- 3. To receive a \$25 Sports Live NFL Free Bet ("**Sports Live Free Bet**") under this Promotion, you must complete these steps in the following order:
 - a. Log into your PlayNow.com account; and
 - b. Make a Pre-Match NFL Football wager that:
 - i. is \$25 or greater;
 - ii. has odds of 2.50 (+150) or greater;
 - iii. consists of Pre-Match selections from games that have not started; and
 - iv. is exclusively placed on NFL Selections. For clarity, wagers including non-NFL selections do not qualify for this Promotion.
- 4. A promotional code is not required for this Promotion.
- 5. This Promotion only applies to the player's first \$25 eligible wager placed during the Promotional Period.
- 6. Same Game Parlays and Standard Parlays qualify for this Promotion.
- 7. Single Bets, Teaser Bets and Combination Bets do not qualify for this promotion.
- 8. Both winning and losing wagers are eligible to receive a Sports Live Free Bet.
- 9. Wagers that would otherwise be eligible but settle as void do not qualify for this Promotion.
- 10. Players are eligible to receive one (1) Sports Live Free Bet during the Promotional Period after they complete the abovementioned steps.
- 11. A Sports Live Free Bet will be awarded within 72 hours of bet settlement.



- 12. A Sports Live Free Bet awarded through this Promotion expires fourteen (14) days after being awarded. An expired Sports Live Free Bet will not be reissued following expiration.
- 13. Wagers placed using a Sports Live Free Bet do not qualify for any other promotion on PlayNow.com.
- 14. A Sports Live Free Bet awarded through this Promotion can only be used for wagering on PlayNow.com NFL sports bets.
 - For clarity, the Sports Live Free Bet cannot be used in wagers including non-NFL selections.
- 15. A Sports Live Free Bet must be accepted as awarded and cannot be exchanged for cash.
- 16. British Columbia Lottery Corporation ("BCLC"), Saskatchewan Indian Gaming Authority ("SIGA") in conjunction with BCLC, and Manitoba Liquor and Lotteries Corporation ("MBLL") in conjunction with BCLC, reserve the right, in their discretion, to adjust or cancel any Free Bet or Token for any reason including if awarded in error.
- 17. BCLC, SIGA in conjunction with BCLC, or MBLL in conjunction with BCLC reserve the right to disqualify entrants and/or entries that do not comply with these conditions, the Player Agreement, or other applicable Rules or Terms of Use (each as defined in the Player Agreement, collectively the ("Lottery Rules")). In the event of a conflict between these conditions and any lottery scheme, the applicable Lottery Rules will prevail.
- 18. This Promotion, Sports Live Free Bets and the use of Tokens are subject to applicable terms and conditions, including the PlayNow.com Player Agreement. See the PlayNow.com Player Agreement for terms and conditions applicable to Tokens.
- 19. This Promotion may be withdrawn, extended, or amended by BCLC, SIGA in conjunction with BCLC, or MBLL in conjunction with BCLC, at any time.
- 20. All stated dollar amounts are in Canadian funds.
- 21. If validation of your PlayNow.com account is pending, the Sports Live Free Bet will be deposited when your PlayNow.com account is validated providing all conditions have been met.
- 22. If you are having difficulty with the Promotion, you must contact Customer Support with issues during the Promotional Period. Any inquiries after the Promotional Period for the applicable offer has ended or the Promotional Period has lapsed will not be considered as eligible for a Sports Live Free Bet.
- 23. All decisions of BCLC, SIGA in conjunction with BCLC, or MBLL in conjunction with BCLC, are final and binding.
